Elaine D. opened the assembly by welcoming everyone to the Fall Assembly and leading the Serenity Prayer.

Introductions were made around the room. New Group Representatives were welcomed, 4 new GR's. 45 were in attendance, and 32 voting GR's.

Secretary's Report – Pam C. presented the Area Assembly Secretary's Report from September 2014. The minutes were approved as corrected.

Treasurer's report – Elaine D. gave Sharon M.'s Treasurer's report.

Old Business

- 501(c)3 – Connie W. gave an update on the 501(c)3 process.

A number of things have happened over the last year,

- We received the Employee Identification number
- We registered with the Secretary of State of Montana and are now registered as a business entity.

- We received notice from the Montana State Department of Revenue requesting information that they need before we are granted tax exempt status.
- We have an attorney in Helena, Brand Boyer, whose specialty is working with non-profit organizations.
- Brand is giving us counsel and guidance on a pro-bono status. When we file with the IRS, hopefully using the short form, there will be a fee for his time.
- I have handed out the By-Laws as they have been framed using the IRS guidelines. These have not been signed, however, they are ready to be signed. At that time, we will be able to file with the IRS.
- Once we have been given approval by the IRS, we will file information with the Montana Department of Revenue.

I have sent out by email, the history of this process. Please note that we have voted and agreed to go forward with this process, there has not been a motion to do so. For my comfort and the procedures of the Montana Area, I am requesting that we have a motion to go forward with this process.

Our Assembly did review and approval By-Laws regarding this process. Due to the requirements and complexity of the IRS, these By-Laws are not what we will be giving to the IRS. However, there is a huge amount of information in this document that can be used as our policy statement.

I would like a committee to continue to work on the details of the process we need to follow in our Area and be able to have a report for you at the Fall Assembly.

At this time, I understand that we will be doing the following:

- We will be filing Federal and State income tax for the tax year of 2015.
- We may need to continue to give information to the Department of Revenue (probably not)
- We will be filing a yearly Annual Report with the Department of State, stating our Directors, mailing address, etc.
- We need to develop procedures to acknowledge any contributions by an individual.
- The treasurer will be tracking income, budget as we do now, however, more detail may be required since we have the non-profit status.
- And I am sure more will be revealed.

Motion C214 has been brought forward to the Assembly reading as follows: Continue the process of applying for non-profit status to completion.

Bev O. and Pennie K. and Connie W. volunteered to write the policies for the 501(c)3.

- Select a Task Force for AWSC Meetings between Assemblies – A Task Force was selected for AWSC Meetings between Assemblies, which are AWSC members. Carole D., Lori K., and Sue P. volunteered for the Task Force.

Committee Updates

- Guideline Committee – Elaine D and Pennie K. worked on and updated the Montana AFG Guidelines yearly with new motions and descriptions of positions. Alateen and AAPP are being updated currently and Elaine will accept any corrections or additions. It is an official document and needs to be correct.
- Area Speaker Meeting Committee – (Pennie K., Elaine D., Carole D., Irene S., Judy, and Lori K.) Carole D. found a room then had to find speakers for the meeting. Carole D. said they would like to keep the speakers local. They would like to pass the basket for tips for the caterer for the event. Discussion was had about some problems with getting the Speaker Meeting set up.
- TEAM Event Task Force – (Carole D., Frances M., Brett H., Patty, Norma, Cindy C., Lori K.) There was discussion that not much was done. After further discussion, it was decided that the Task Force be given a charge to “establish a place and date for the next TEAM Event.” This committee is going to meet for 15 minutes after the Assembly.

Delegate Report

Connie W. read the daily reading out of Al-Anon’s daily reader *Hope for Today*.

This is a preview of information to share with you regarding the upcoming World Service Conference, held in Virginia Beach, Virginia, April 19 through April 24, 2015.

I am really very excited to be going this year. I finally think I know what I am doing!

There are going to be three International visitors attending from Germany, Mexico and UK & Eire.

There are two Conference Agenda Items:

First Topic for 60-minute discussion: Chosen Agenda Item #5

CAI:

Is the current model of Alateen the best model for the future of both Al-Anon and Alateen?

Explain the importance of this CAI and how it could shape Al-Anon as a whole:

In Bill’s “Essay on Leadership,” he speaks of revisiting past decisions to see how they’re working out. Much has changed in Society since the advent of Alateen safety and behavioral Requirements. Cellphones and texting are now the norm for teen communication, background checks (and the administrative costs associated with them) are common and schools, once welcoming, are now reluctant to deal with us for fear of litigation over the inclusion of the three legacies. In short, is Al-Anon wasting resources maintaining the current model of Alateen? If so what changes should be made?

CAI:

The importance of Alateen to our Al-Anon programs.

Explain the importance of this CAI and how it could shape Al-Anon as a whole:
I would like to see work done for Alateen to:
Get Al-Anon members interested in being Sponsors, Coordinators, and AAPP.
Get teens interested in Alateen and Service they can do.

CAI:
In some Areas, what is stopping our kids from coming to Alateen?

Explain the importance of this CAI and how it could shape Al-Anon as a whole:
The Alateen Groups are up and running and we are not getting the teens to some of the groups.
What could be stopping the kids from coming to Alateen?

Second Topic for 60-minute discussion: Chosen Agenda Item #3

CAI:
How can we clarify our primary purpose while welcoming members who need our program who may have a drug addicted friend or family member?

Explain the importance of this CAI and how it could shape Al-Anon as a whole:
Many people are coming into Al-Anon affected by others having problems with both alcohol and other substances, or sometimes only other substances. Our primary purpose is to help families of alcoholics and our only requirement for membership is a problem with alcoholism in a relative or friend.

Some groups respond by stating Al-Anon is for families of alcoholics and addicts, although that is inconsistent with Tradition Five. If groups do not have strategies to welcome newcomers in a manner that protects Al-Anon's focus while encouraging them to determine for themselves if they belong, we risk Al-Anon's ability to offer recovery.

CAI:
Is Al-Anon becoming friends and families of addicts? Is the focus more on addiction than alcoholism? Are we diverted from Tradition Three and Tradition Five? How can we support groups and maintain Al-Anon's primary aim? Is the Al-Anon program being diluted?

Explain the importance of this CAI and how it could shape Al-Anon as a whole:
I continue to hear more talk of addiction instead of alcoholism at all service levels and within the groups that I attend. Our responsibility is to ensure Al-Anon's survival as a resource for families and friends of alcoholics. How do we ensure Al-Anon's survival as a fellowship for families and friends of alcoholics? There are many different types of addiction and we risk our program being diluted more and more as different types of addiction are entering our meetings.

The discussion for the "Big Question" continues.

The 2014 Big Question was, "**How can we as service leaders anticipate the future and Al-Anon's place in it, ensuring that the necessary resources are available with our spiritual principles as our guide?**" During discussions, members tried to anticipate Al-Anon's place in the

world 15 to 25 years from now. Contemplating the year 2051, Al-Anon's one-hundredth anniversary, was challenging. Among the topics discussed were societal changes affecting members and groups; technology influencing communication among members and groups; meeting formats; links within the service structure; self-support; and the role of our clearinghouse—the World Service Office (WSO).

This year the question being asked is **“How do we envision responsible service leadership in Al-Anon, a vision that inspires today's members to be tomorrow's leaders who are motivated by spiritual principles?”** This year's Big Question focuses on our vision of service leadership in the next three to five years, a time span that perhaps we all can better “see.” Concept Nine reminds us a “good idea can come from anywhere,” and “anywhere” is well represented at the 2015 World Service Conference with attendees from Bermuda, Canada, Puerto Rico, the United States, Germany, Mexico, and the UK & Eire. We Conference members represent the largest group conscience for Al-Anon and are a valuable resource for Al-Anon Family Groups. As today's leaders, we have the opportunity to share our vision of Al-Anon's future service leadership.

There will be a discussion on Memorial Contributions. This has been a topic of conversation which has come up due to a variety of questions that have arisen throughout the years beginning in 1962.

At the 2013 World Service Conference (WSC), a Policy conversation began on accepting memorial contributions from a non-member on behalf of his or her deceased family member who belonged to Al-Anon. This conversation came at the request of the 2011 WSC in response to a discussion on identifying information for a guideline on memorial contributions.

The Policy Committee began the discussion in July 2011 in light of Tradition Five and “giving comfort to families of alcoholics.” Once this Tradition was fully explored, the Policy discussion expanded to include a review of all Legacies and extensive archival research.

At the 2013 World Service Conference (WSC), members shared their opinions on the Memorial Contributions presentation, which included the archival timeline. Delegates were provided on e-Communities in preparation for this discussion. During the discussion, members requested clarification on the definition of “family,” “member,” and whether there would be a limit on the memorial contribution. WSC members also requested safeguards to ensure no undue influence or “ear-marking” and questioned whether a change to Al-Anon's policy would affect AA as a whole. At the end of the 2013 discussion, the Conference members requested the conversation continue.

At the 2014 World Service Conference, in response to the work of the Thought Force, Conference members discussed the definition of “family” and “member”. Due to time restrictions, the discussion was unable to reach conclusion. Conference members requested to continue the discussion at the 2015 World Service Conference.

Before we begin our discussion, members of the Policy Committee will present the information requested from the 2013 WSC. We look forward to this on-going conversation and your thoughts on this topic.

There will also be presentations of task forces, thought forces and committees. So as we say, “more will be revealed”.

Public Outreach has been active in running ads in the local newspapers during the holiday season. Eve M. is also continuing to work with Missoula's Recover Center. This is a big deal for our community as we didn't have an inpatient facility for Alcohol for a long time. Currently we have a group of volunteers that go in on family day and explain Al-Anon, share a bit, and answer any questions.

We have a small committee working to get Al-Anon information into the packets that are given to domestic violence victims.

Patty K., the alternate DR and I are starting to plan for elections this fall for the new term in 2016. We learned so much, made a lot of mistakes, and am so grateful for the experience! We've been having the most amazing concept studies every other month. I've noticed that I really look forward to these meetings and am so honored to serve with our district. I am so grateful to be a trusted servant.

- District 14 – Red Lodge – given by Katy K.

We currently have four meetings in our district, all of which are going well.

The largest meetings are on Wednesday evenings – one in Absarokee and one in Laurel. Attendance runs between 10 and 15 people at those. The Laurel Monday afternoon meeting has three very loyal members and they've been going strong for years. Red Lodge regularly has 5 to 8 people in attendance. It began in 2011, so is the newest meeting, but has very loyal attendees.

Our next district meeting is coming up shortly, but date is not set.

➤ District 9 – Butte – given by Chris K.

Thank you for the opportunity to be here. This has been a fast moving year. Our Alateen group started successfully 4 days after Fall Assembly. We had 1 member, then two more joined. Two of the members moved out of Butte and the third girl lost interest and stopped coming. In January our two Alateen sponsor requested we return to inactive status. We remain inactive at this time, however, both the AMIAS are willing to sponsor and restart our Alateen meetings at any time if someone comes forth for Alateen. We have distributed posters to the schools and have distributed the bookmarkers with the Al-Anon hotline number, Montana Al-Anon/Alateen website and Alateen online meetings.

In October we had a Halloween party for Al-Anon, Alateen and AA and their children. We had a very good turnout. Everyone donates treats, the district buys pizza and we play games for the youth. We look forward to wearing our costumes and watching the children have fun.

We had our business meeting in January and have made considerable improvements in our treasury from fundraising. We are asking groups how they would like us to spend it. So far suggestions have been made to do Speaker meetings, workshops and panels. We had our annual Italian dinner on March 21, 2015 with an Al-Anon and AA speaker. This year we expanded our pasta selections and as usual it was well attended. AA in District 9 is very supportive of Al-Anon. Many help to set up and clean up and also bring food items.

We have discussed the Elections for the Area, District and Group service positions. Resumes have been distributed. We plan to vote in our District before June 1, 2015 for new Group Representatives and District Representative by the fall before Assembly.

District 9 has 7 meetings, Butte on Monday, Wednesday and Thursday, Anaconda on Tuesday and Thursday. Deer Lodge Tuesday night and Dillon Monday night. All but Deer Lodge have Double winners. Our estimated total members count from all Active groups is 50 to 56. Our meeting format ranges from regular meetings per the suggested meeting plan to reading of Al-Anon books, studying the Traditions. We hope to have an Alateen group in the future.

Our newest order of business is to gather interest in an Al-Anon meeting at the Alcohol Treatment program in Warm Springs, Montana. We are discussing this with the members of all the groups as most of our cities are close to Warm Springs in our district. Our goal is to stir up interest in outreach in the treatment programs and perhaps will affect the attendance in our groups to spread the Al-Anon message.

This time I have spent in Al-Anon has given me so much insight and growth. I appreciate the opportunity to serve with all of you and look forward to seeing you this coming fall. God willing you have a safe trip home.

We meet the second Wed evening of each month except December in the Fellowship Hall in Bozeman.

Our primary fundraiser, Gratitude Festival, was held November 22, 2014 at the Fellowship Hall in Bozeman. We changed it to an afternoon event in hopes it might be more family friendly.

Our attendance was down from our evening events. We had a potluck, Rick and Connie W were our speakers, a silent auction featuring gently used items and fabulous baked goods auction. It was great to have folks from Helena drive down to join us. Lots of fun was had and is a great gathering for our recovery community. We invite you to put together a road trip and join in the fun.

We have been working on the first ever budget for our district and just passed it at our last meeting. We discovered that we were spending as much money as we were bringing in and not necessarily meeting all the commitments we would like to. So is a start and will adjust as we go along. So have put some things we were planning on doing on the back burner for the moment. Next we will be determining a prudent reserve.

We have several new GRs which is very exciting to see more groups become more active in district as well as to see new faces for groups that continue to be active.

Our district website has become much more active posting our current district officers and contact info, current meeting schedules, events happening in our district, as well as job descriptions for our district positions. Our district website is also linked to the area website. We have combined our Archives position with that of a web coordinator.

The Detention center had made a request we provide them with the paperback copy of How Al-Anon Works and our public outreach coordinator is also investigating information available for our Spanish speaking community.

We do have several service opportunities available in our district and continue to take this positions back to our groups and talk to members about these opportunities.

We had an interesting request from a group last month to be added to our meeting list. The group was a combined AA and Al-Anon meeting. We told them that we would need to do a little more research before adding their meeting to our schedule. I contacted WSO and explained the situation and asked for guidance. They were very quick to respond and very helpful. They confirmed our concern about being in violation of Al-Anon's traditions and also passed on info on a pamphlet that very specifically addresses how AA and Al-Anon cooperate together and that neither will knowingly register a combined meeting. The meeting had not yet been registered with WSO so were able to avoid any potential controversy and simply explain the reasons why we could not add this meeting.

In October, Pennie K, our Area Alateen Coordinator came to Bozeman and did an Alateen Sponsorship workshop. We are now able to provide training for new sponsors in Bozeman.

In January our Saturday Morning meeting celebrated their 11th anniversary with a AA speaker, Al-Anon speaker and a wonderful Alateen speaker followed by a potluck.

The New Leaf Women's Group hosted a panel workshop on Relationships in February and have another Workshop planned for May.

This phone provides basic information on how to find a meeting as well as the opportunity to leave a message for needed 12-step calls or if additional information is desired. Elaine D. is the new Information Line Chair & she has a small committee of people that take turns holding the phone. Other than a few glitches with renewing the service, this is working well for our district.

We have 13 active groups in our district...12 in Billings and one group in Pryor. The Friday Serenity group changed their meeting time from 8:00 to 7:00 (PM). The groups in Hardin & Wyola are inactive. Our most exciting group news is that we have a NEW registered Alateen group! We also have an Alateen chair person, Kelsey M., who is very excited about her position and is hoping to get Alateen into at least one other site in Billings.

Constance H. is our Institutions Chair person and she is the liaison for our three institutions meetings (Passages, Newcomers, Rimrock). The district hosts a Newcomer’s Meeting weekly and a “Meeting on Wheels” for Rimrock family week every 4 weeks. These meetings each have 2 co-chairs, and the groups within the district sign up to support the meetings.

The meeting at Passages (the women's pre-release center) is going well and we are preparing for the second year of training/orientation, which is a requirement for all volunteers at this program. The group uses One Day At a Time (B-6) for the weekly meetings but the books must be returned to the Al-Anon tote at the end of the meeting. We are allowed to leave copies of the Forum magazine and the women really appreciate these. The District also purchased several copies of the softcover How Al-Anon Works (B-32) for the Passages library; these are available for the women to check out and read as they wish.

Kathy M. is our Public Outreach person and she keeps all the district meetings updated on the Billings Gazette website. She is also distributing literature around the community on a regular basis & participates in health fairs, etc. when possible. Hello Everyone,

I am Bev O. Montana Area Group Records Coordinator. For anyone who is new, my job is to make sure WSO has accurate information about Montana's Al-Anon meetings. I also notify Area trusted servants about new groups, changes in contact information and new Group Representatives. I notify the webmaster about new or inactive groups and changes in meeting days, times, or locations.

Montana now has 146 Al-Anon groups. One hundred fourteen of these are active and 32 are inactive, including 10 that are marked for deletion. That means those 10 groups have been inactive for many years and they will be dropped completely from the current records.

We have 3 new groups that have registered since the Fall Assembly. They are: West End AFG in St. Regis, Noon AFG in Polson, and Finding Peace With AFG in Culbertson.

There are 5 active groups in Montana with group email addresses that bounce back to WSO. They are Courage to Change in Bigfork, Scobey AFG, Colstrip AFG, Tuesday Night in Great Falls and Harlowtown AFG. If we are notified of new email addresses for GRs we don't change the Group's email address. If group emails are to go to the new GR, you need to tell us that.

I've placed group detail reports for each district in your mailboxes. They look like this. I've highlighted "inactive" when that applies and have noted which groups have "bouncing" email addresses.

I have been thinking about the question of who can make changes to the site. I believe there may be a way to do this: if each district page is converted to WordPress, (Open Source) then the DR's or Group Records coordinator from the Districts could then update the changes. I will need to research this idea and talk to people that have more experience in web design and maintenance.

Brett and I did not find the time to get together and teamwork for the site. This is still a plan/hope for the summer.

I did not cleanup the web site data. Currently there is about 80mg of 100mg allowed.

In reviewing the Area Guidelines, prior year's meeting minutes, and similar documents that should be posted; there are Full Names throughout these documents, which will need to be edited to maintain anonymity prior to posting to the Web. Once this has been corrected, each document will be saved as PDF so not to allow editing after the document is posted to the Web.

Again, when the district sets up a new meeting, the form that is submitted to "Group Records", if filled in completely should provide the information needed to update the website. This data can only be posted to the website after the new group receives their Group Number from WSO. (Please ensure the District number is included with this data). I have received changes and new meeting information with no District included, I do not know where many of the Towns are in the state, or which District they may be attached.

Events you have coming up. If they are AA with Al-anon participation and the AA has a flier on the internet we can add a link to that.

Basic requirements for posting: Consistent with the Al-Anon principle of anonymity, any data containing last names will not be posted.

I will not be at the 2015 Fall Assembly in Lewistown.

Hello Area Assembly!

The News & Views is a resource for state event information and Area news. We work closely with the website coordinator to post links to event flyers as well as making archived copies of the newsletter available. We have published seven issues of the newsletter since the last assembly.

Montana AFG started sending the News & Views (N&Vs) electronically January 27, 2010. This replaced the paper copies mailed to groups and members. Our email vendor, iContact, gives us a yearly, prepaid, non-profit rate of \$73.09 per year, or a cost of \$6.09 per month. There won't be an increase in the annual subscription amount until we hit 500 subscribers; we are currently at 298, including 32 since last assembly. It's great to get notice of new subscribers every week. One of the great benefits of using the iContact software is it manages the email distribution group for us.

Couple of reminders/tips:

You no longer see the "Forward button at the bottom of the email". iContact removed that option due to Canadian regulations following the DMARC changes. You may forward the issue from your email client or sign up via the button on the website.

Recipients can manage their account profile by using the link at the bottom of each newsletter. The most common update would be an email address change. If you are a group representative, our Area Group Records Coordinator, Bev, will be asking if you are receiving the News & Views. She is willing to assist to get you on the mailing list.

Please share your ideas on how we can make this newsletter better. We can always use short articles from the Area coordinators and District Representatives.

One thing I would like to propose is considering a new name for this newsletter. I do not know the history of the title "News & Views"; I feel like it is only 'news' at this point and suggest we could come up with something different.

Looking ahead, I'm looking for an 'understudy'. The elections for the next three-year coordinator terms are coming in the fall. Deb L., has been available to assist me with editing and graphics. We are asking if there is someone in the assembly who is interested in assisting with the newsletter production. We are willing to start orienting someone new to the mechanics of the newsletter process if someone plans to stand for this position.
