Secretary's Report – Pam C. presented the Area Assembly Secretary's Report from April 2015. The minutes stand as corrected.

Treasurer's report – Pennie K.

The Budget for the last 2 years has been close to 10,000 in expenses income has been average 7,000 the amount of groups that donate is about 50 percent

7000.00 / 50.00= 140.00 that means about 50 groups have paid an average of 140.00 to cover expenses of 10,000 those 50 groups would need to contribute 200.00 if all of the groups in Montana could contribute to the Area they would need to contribute 100.00 to be self- supporting.

Actual contributions were around 2000.00 less than the expenses. This year we are at this time we are at about 6000.00 contributions 2000.00 needed to go to last year's expenses so we are at 4000.00 we will need 6000.00 in contributions to meet the budget expenses for this year.

Expenses are going up for the Assembly the good news is that we are now a 501 (c) (3) personal contributions are tax deductible.

The last couple of assemblies I have heard does your group have a budget? I have these questions to put to you today

Does your group need a budget? What Items do you need to put on your budget? Rent, CAL, New comer info, (Groups at Work books, How Al-Anon works soft cover), Sending your Group Rep to Assembly. District, Area, WSO, Coffee snacks. How do I contribute to the group so it can meet its budget? We see that the Area spends about 100.00 per group to carry out the duties of the Area The WSO spends about 250.00 per group to cover the WSO budget. Some groups do not get enough 7th tradition to pay the rent

Old Business

➢ 501(c)(3) − Connie W. gave an update on the 501(c)3.

The process to become a non-profit entity with 501 (c) (3) is complete.

Here a listing of the number of things have happened over the last year:

- We received the Employee Identification number (EIN) in 2014. We needed to change the EIN due to our name change to Montana AFG, Inc.
- We registered with the Secretary of State of Montana and are now registered as a business entity.
- We received notice from the Montana State Department of Revenue requesting information that they need before we are granted tax exempt status, which was done in 2015. With this info, we received documentation that we had filed the Articles of Incorporation and had fulfilled the requirements set forth in law, with the effective date of, September 24, 2014.
- Brand Boyer, an attorney who specializes in non –profit companies, gave us counsel and guidance on a pro-bono status. Our costs to him were \$69.00 and the \$450.00 that it cost to submit the short form for the 501 (c) (3) to the IRS.
- The By-Laws which were framed using the IRS guidelines were signed and filed with the IRS.
- On May 15, 2015, we received the letter from the IRS stating that we are exempt from federal income tax and the Internal Revenue Code (IRC) Section 501 (c) (3). We are classified as a public charity.
- We were required to file Form 990-N, which was done and accepted 6/25/2015.
- The Business Entity Annual Report was filed with the Secretary of State office 4/8/215.

Going forward:

- We will NOT be filing Federal and State income tax unless we have savings account interest in excess of \$1000 for the tax year according to the Montana Secretary of State office.
- We will be filing a yearly Annual Report with the Department of State, stating our Directors, mailing address, etc. between January 1 and April 15 each year.
- We will be filing a Form 990-N for the IRS. The annual information return is due by the 15th day of the fifth month after December 31.
- We need to develop procedures to acknowledge any contributions by an individual.
- The treasurer will be tracking income and budget as we do currently.

Good Afternoon Everyone,

I'm Bev O., your outgoing Area Group Records Coordinator It is the Group Records Coordinator's job to make sure the WSO has accurate information about each group in Montana and to keep the Area informed about contact information for each group.

So, here are this fall's statistics: Montana has 113 active Al-Anon groups, plus 26 inactive and an additional 10 inactive that are marked for deletion. There are 3 new groups since Spring Assembly: A Path to Serenity AFG in Libby, registered in May Good Morning Higher Power AFG in Helena also registered in May, and Flathead Parent AFG in Whitefish registered in August.

We have 4 groups in the "Bounced Emails" category. These groups are: Scobey AFG, Tuesday Night AFG in Great Falls, Searching for Serenity AFG in Roundup, and Harlowton AFG.

I recently received a memo from Valerie Stump, who is Group Records Coordinator at the WSO. She describes what has been done to clean up meeting location instructions in the database. There is a copy of this memo for each district in your mailbox.

The other item I placed in your mailbox is the current list of groups in each district with their meeting and contact information, etc. This is what the WSO has; so if anything is incorrect, please let me know about that.

Every group in Montana should have received an update form from WSO in July. It is helpful if those are returned even if there are no changes that need to be made. That way, WSO knows that what they have is current. Also, you need to know that WSO does not send those forms on to the Areas. If there are any changes in meeting information, or if you have a new GR (for example), the only way we find out about that is if you contact us.

Does anyone have any questions?

I have thoroughly enjoyed being your Group Records Coordinator. This is a position I highly recommend for anyone who likes to keep track of details and who likes to work and

communicate online. I have some information to pass on to whoever is elected tomorrow, so please see me before you leave.

Hello Area Assembly!

The News & Views is a resource for state event information and Area news. We work closely with the website coordinator to post links to event flyers as well as making archived copies of the newsletter available. We have published four issues of the newsletter since the last assembly.

Montana AFG started sending the *News & Views* (N&Vs) electronically January 27, 2010. This replaced the paper copies mailed to groups and members. Our email vendor, iContact, gives us a yearly, prepaid, non-profit rate of \$73.09 per year, or a cost of \$6.09 per month. There won't be an increase in the annual subscription amount until we hit 500 subscribers; we are currently at 312, including 14 since last assembly. It's great to get notice of new subscribers every week. One of the great benefits of using the iContact software is it manages the email distribution group for us.

Couple of reminders/tips:

- You no longer see the "Forward button at the bottom of the email". iContact removed that option due to Canadian regulations following the DMARC changes. You may forward the issue from your email client or sign up via the button on the website.
- The easiest way to subscribe via <u>Montana Al-Anon website</u>. There should be a <u>button</u> that says "sign up for our newsletter".
- Recipients can manage their account profile by using the link at the bottom of each newsletter. The most common update would be an email address change. If you are a group representative, our Area Group Records Coordinator, Bev, will be asking if you are receiving the News & Views. She is willing to assist to get you on the mailing list.

Please share your ideas on how we can make this newsletter better. We can always use short articles from the Area coordinators and District Representatives.

The elections for the next three-year coordinator terms occur tomorrow. Deb L., has been available to assist me with editing and graphics. She is the District 7-elect for Billings. Is there someone in the assembly who is interested in assisting with the newsletter production? I am ready to begin orienting someone to the mechanics of the newsletter process if someone plans.

There is a link to view and print the newsletter outside of your email client. Under the heading banner, there is a link that says "if there are problems with how this message is displayed, click here to view it in a Web browser."

We meet the 2nd Monday of every month (except July); 6:30PM at the El Corral restaurant. We are still without a District Secretary & this continues to be a challenge at our monthly meetings, but we manage.

We have a local Literature Distribution Center (LDC). Our Literature Chair is Audrey W; she can be reached at 406-248-8433 and she has a new email address, which is <u>litdisctr@gmail.com</u>

We use a TracPhone for our information line: 406-694-5332. This phone provides basic information on how to find a meeting as well as the opportunity to leave a message for needed 12-step calls or if additional information is desired. Elaine D. is the Information Line Chair & she has a small committee of people that take turns holding the phone. This is working well for our district.

We have 14 standard Al-Anon groups in our district...12 are in the Billings/Lockwood area. The Tuesday Hardin group is again active, and the Pryor Hope group will be celebrating it's 3rd year anniversary with an Open House & potluck supper this coming Monday (September 21st). We have one registered Alateen group that meets on Sundays at 1:30. This summer, Billings Alateen also opened a separate bank account.

Constance H. is our Institutions Chair person and she is the liaison for our three institutions meetings (Newcomers, Rimrock & Passages). The district hosts a Newcomer's Meeting weekly and a "Meeting on Wheels" for Rimrock family week every 4 weeks. These meetings each have 2 co-chairs, and the groups within the district sign up to support the meetings.

The meeting at Passages (the women's pre-release center) is going well and six Al-Anon members went through the second round of training/orientation this year, which is a requirement for all volunteers at this program. The group uses <u>One Day At a Time</u> (B-6) for the weekly meetings but the books must be returned to the Al-Anon tote at the end of the meeting. We are allowed to leave copies of the Forum magazine and the women really appreciate these. The District also purchased several copies of the softcover <u>How Al-Anon Works</u> (B-32) for the Passages library; these are available for the women to check out and read as they wish.

Kathy M. is our Public Outreach person and she keeps all the district meetings updated on the Billings Gazette website. She is also distributing literature around the community on a regular basis & participates in health fairs, etc. when possible. She has been doing lots of work with the local hospitals, clinics & colleges.

On August 29th, the District hosted a Picnic in the Park. This event included speakers from Al-Anon and AA, as well as games and a potluck supper. The affair was well attended by members from both programs and we intend to make this an annual event.

Twice we have attended business meetings with District 14...on Apr. 25th in Columbus, and again for "Christmas in August". For the third year in a row, members of our district traveled to Coeur d'Alene for the Serenity Cruise last week...we grow in numbers every year, and this time we had 7 total in 2 cars! We will continue to look for opportunities for a road trip...

This is my final Assembly as District Representative for District 7. I want to thank the District members for allowing me to serve in this capacity. Of course, we are our own worst enemies and I fall short of my own expectations. But you have allowed me to stumble without judgement. You have picked me up and brushed me off. Comments from Ric, Executive Director

- There will be 100 copies of Spanish Courage to Change printed. When those run out, more will be printed.
- > Conflict Resolution kit is available in Spanish and French.
- Meeting info from the WSO website will be live. As soon as the Group Records are entered will be available on the website. Also included will be meetings that have been delisted, phone meetings, on line meetings. They will also be available in French and Spanish.
- There is going to be a new community platform "AFG Connects". The platform will be open to all. Anything that is an announcement will be here. Example, Group e-news, Area Highlights. There will be able to have documents attached. There will be a search feature. Members will be able to determine their own logon and password information. There will be videos to teach us how to use it. All members will be able to access this site. It will be going live this October. It will also be able to be used by IPhone and tablets.
- WSO is purchasing a new program that will allow the Alateen chat site to be available on mobile phones. It will be available this summer.

Area Dreams.

What are our area dreams, district dreams? What is the dream Alateens have for Alateen? This was a great workshop. We were encouraged to think outside of the box, to have no limits in our desires. We discussed what kind of resources we would need, how much time would it take to reach the goal.

Finance information.

- In 2006. The Finance committee was thinking abundantly and they budgeted for \$1,500,000 in contributions. In 2014, Contributions totaled \$1,512,388, an increase of 8.2% Over 2013.
- ▶ In 2014 the average cost of services per group was \$256.87.
- ▶ The estimated cost of services that were provide was \$3,970,232.

Montana information.

- ▶ 49.1% of groups donated for an average amount per group of \$126.57.
- Total group donations in 2014 were \$6,708. In 2013, donations were \$5,979.

Other contributions include individuals and contributions from LDC's and area and district meetings.

The majority of income continues to be derived from literature. If the groups who contributed last year added \$5.00 to their contribution, the budget would be met without the need to go into the reserve fund. If groups who contributed last year added \$25.00, the contributions would total \$1.7 million. THERE IS ABUNDANCE IN GRATITUDE.

Is Al-Anon becoming friends and families of addicts? Is the focus more on addiction than alcoholism? Are we diverted from Tradition Three and Tradition Five? How can we support groups and maintain Al-Anon's primary aim? Is the Al-Anon program being diluted?

This was discussed at the Conference as well as our meeting last spring.

Chosen Agenda Item #5.

Is the current model of Alateen the best model for the future of both Al-Anon and Alateen? The importance of Alateen to our Al-Anon programs.

In some Areas, what is stopping our kids from coming to Alateen?

This was discussed at Conference as well as our meeting last spring. There is not a move to discontinue Alateen. What do the Alateens want in their program?

Lois's Story

Lois's Story (AV1) and *Lois and the Pioneers* (AV-24) has been available in VHS Format. The demand for the stories have been very low. However, Arizona wanted to use it at a conference. Since it is Conference Approved Literature, they were not able to copy it to a DVD. A motion was made to convert the two stories to DVD copy protected. All members will be able to access these stories through the WSO.
